## A message from Kung Fu Kids

Welcome to term four! It's hard to believe it's already October.

Kung Fu Kids has grown quickly thanks to your support. So that we can keep up the good work with the kids and our schools, we'd like to announce some changes for term four.

### A change to fees

Most importantly, we're changing our fees in response to feedback from parents. Fees can now be paid for a whole term or by the week:

- \$75 a term; or
- \$10 a week.

Paying by the term saves us and we'll pass that saving back to you. You can also make online payments using your credit card via Mastercard or Visa. A term will cost \$77.00 and a week \$11.

To allow instructors to focus on lessons, we'd prefer that payments be made by posted cheque or online. Of course, you can still pay by cash or cheque, though we ask that this be kept to the minimum if possible.

If you've paid for the first week or month but would like to pay for a term, please let us know and we will arrange this.
